RULES & FORMAT:



- Kids 7* -17 must have previously attended a **DRIVER TRAINING SESSION** or have participated in a GHSBD NDR Rally to drive a derby car. See website for New Driver Training dates. * Kids currently in the first grade and will turn 7 sometime during the current school year.
- Two-seater cars with a driver will be provided for kids ages 4+, kids with special needs and those who have not previously attended a driver training session (must weigh less than 150 lbs).
- Driving instruction and push test required for all adult drivers.
- Participants will receive a wristband after driver training--which will be color-coded for the type of car required.
- **FIRST RUN** participants will be staged first.
- There will be an **ADDITIONAL RUNS** line; participants must have a color coded wristband.
- Cars and helmets are provided. You may bring your own DOT-approved bicycle helmet.
- Shoes are required. Please--no flip-flops.
- No smoking, skateboards, bikes, scooters, balls, frisbees, etc., allowed at derby events.
- If you want to race someone, you should get in line with that person. **NO CUTTING IN LINE.**

A "Family Team" Activity: A team consists of kids and adults, with at least one adult being physically capable of assisting with car handling for their team members and possibly for other teams. Car handling activities involve lifting cars on and off trailers and positioning cars in the starting gates. GHSBD promotes safe derby car driving and handling procedures at all events.

Registration Form: All Public Fun Day / Night participants must print, complete, sign and present at the event registration desk the release form provided by Harris County Pct. 3.

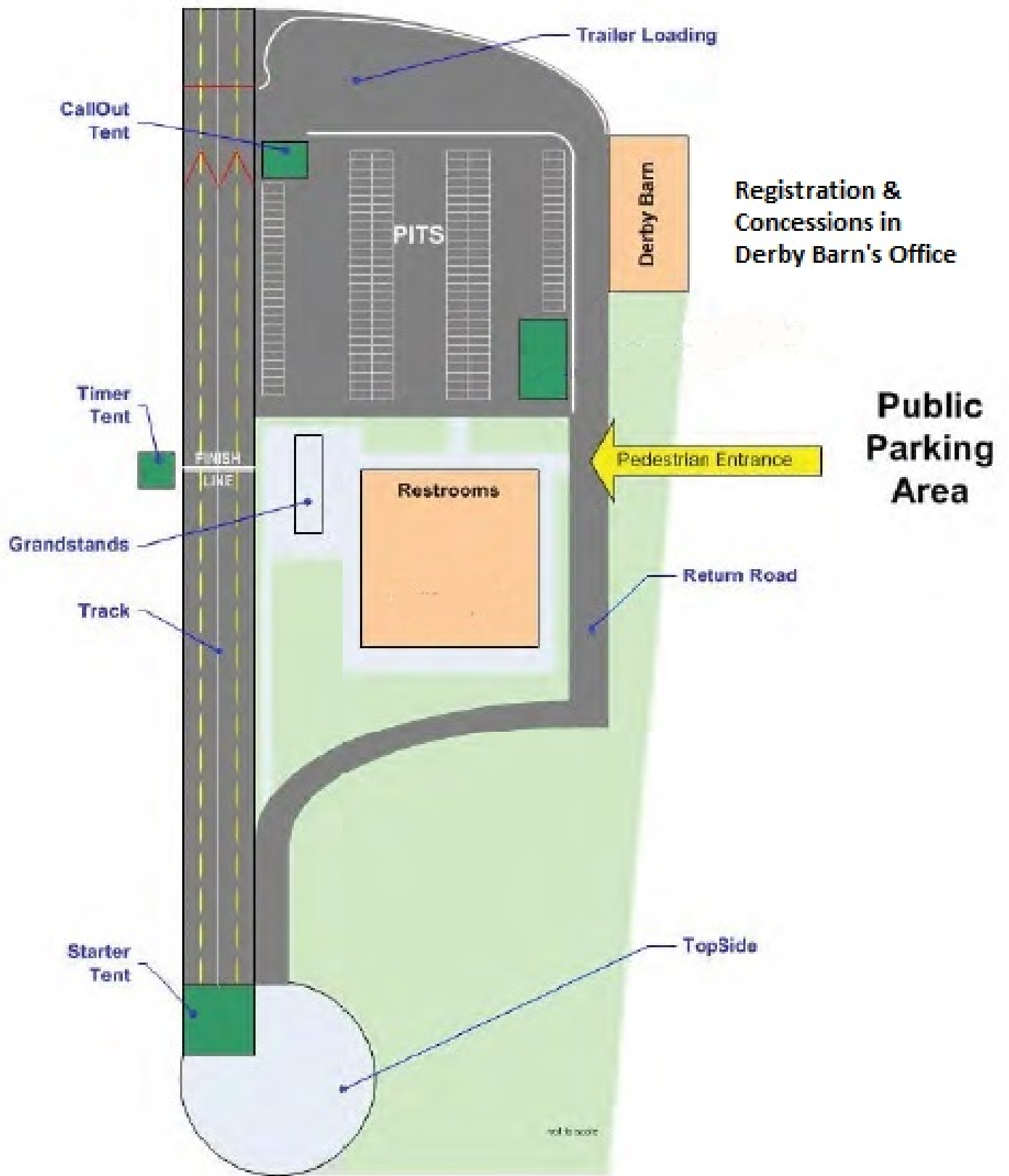
Event Release Form

Volunteers Needed: The success of all GHSBD events depends upon volunteers. Please encourage all interested adults and high school/college-age students to contact GHSBD to get involved. 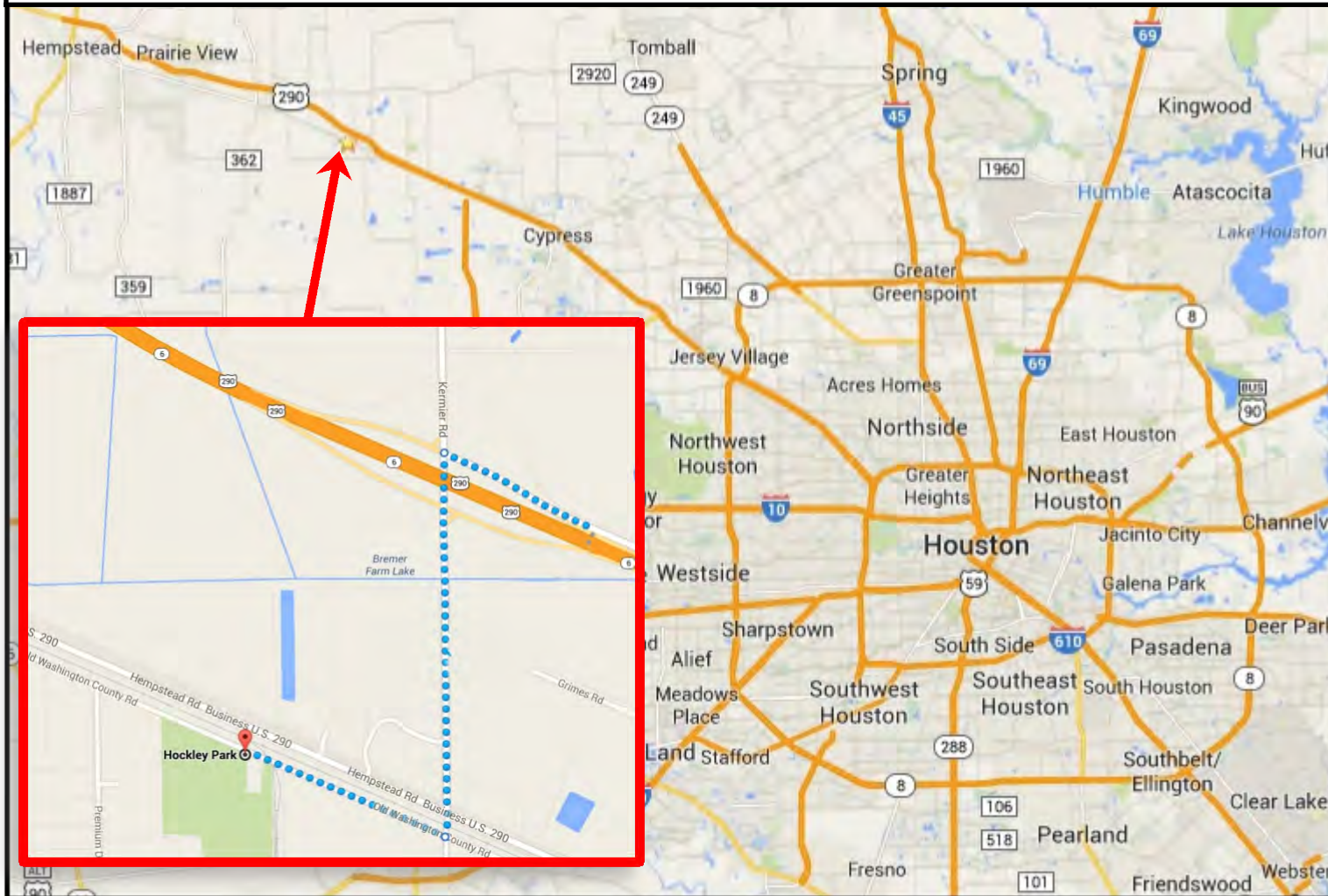

INDEMNITY. USER SHALL INDEMNIFY AND HOLD HARMLESS COUNTY AND COUNTY'S AGENTS, EMPLOYEES, AND OFFICERS OR OTHER REPRESENTATIVES FROM AND AGAINST ALL COSTS, EXPENSES (INCLUDING REASONABLE ATTORNEY'S FEES AND COSTS), SUITS, CLAIMS, DEMANDS, LIABILITIES, AND ACTIONS (COLLECTIVELY, "LOSS") RESULTING FROM ANY BREACH, VIOLATION, OR NONPERFORMANCE BY USER AND USER'S EMPLOYEES, SERVANTS, AGENTS, CONTRACTORS, LICENSEES, CUSTOMERS, OR INVITEES, OF ANY PARK REGULATION OR FROM THE USE OF THE PARK FACILITIES BY USER OR USER'S EMPLOYEES, SERVANTS, AGENTS, CONTRACTORS, LICENSEES, CUSTOMERS, OR INVITEES OR FROM ANY ACT, OMISSION, OR NEGLIGENCE OF USER, USER'S AGENTS, SERVANTS, EMPLOYEES, CONTRACTORS, LICENSEES, CUSTOMERS, OR INVITEES OR FROM ANY OTHER CAUSE WHATSOEVER. THIS INDEMNITY SHALL APPLY REGARDLESS OF WHETHER THE LOSS IN QUESTION ARISES IN PART FROM ANY NEGLIGENT ACT OR OMISSION OF COUNTY OR COUNTY'S AGENTS OR EMPLOYEES, FROM STRICT LIABILITY OF ANY SUCH PERSONS OR OTHERWISE.
